

ELK RUN CEMETERY COMMISSION MINUTES

April 11, 2002

Cemetery Commission Members Present: Bob Whitfield, Gerald Monger, Lillian Nicholson, and Betty McGahey.

Staff Members: Lynn Meadows and Lee Dearing.

Chairman Bob Whitfield opened the meeting with devotions.

The minutes of August 22, 2001 meeting was approved with the following amendment: A motion was made by Scott Baugher and seconded by Gerald Monger that we purchase approximately 2.739 acres at \$17,000. per acre on the north side, with first option to purchase remainder of land.

Cemetery Director - Lynn Meadows asked for a motion that no space be opened for internment until Perpetual Care is paid. Motion made by Lillian Nicholson and seconded by Gerald Monger. Motion was unanimously passed.

Cemetery Director - Lynn Meadows also asked for permission to sign Contract with Mr. Donnie Merica to maintain the Cemetery from April through October. Motion made by Betty McGahey and seconded by Lillian Nicholson.

Gerald Monger reported attending Rockingham County Board of Supervisors Public Hearing and Meeting concerning Special Use Permit from County for new development of Cemetery addition. He reported this was approved.

Money for addition and improvements of Cemetery be taken from Real Estate Account. The approximate cost for addition and improvements are as follows:

1. Purchase of Land	\$47,090.00
2. Developing New Section	\$77,773.63
3. Paving Existing Roads	\$32,104.80
4. Storm Sewer in Existing Section	\$ 8,707.48
Total for Land and Improvements	\$165,675.90
